

Articles of Organization

We, the undersigned, in order to establish a nonprofit Limited Liability Company under the laws of the State of Montana, hereby certify as follows:

Article I: Name

The name of the Limited Liability Company shall be PixelQuest Ventures LLC, hereinafter referred to as "The Organization".

Article II: Principal Office

The principal office of The Organization shall be located at 1180 Otis St, Apt A411, Missoula, MT 59802, or at such other place as the members may from time to time determine.

Article III: Purpose

PixelQuest Ventures LLC is organized exclusively for charitable, educational, and community service purposes within the meaning of Section 501(c)(7) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

The primary purpose of PixelQuest Ventures LLC is to serve as a catalyst for community enlightenment and growth, leveraging digital platforms to promote social well-being, digital inclusion, and community engagement.

Key aspects of our purpose include:

- Online Community Building: We strive to create a welcoming online environment where members can connect, share ideas, and engage in meaningful discussions. Our platform hosts various artists, social events, and awareness campaigns to foster creativity, connection, and social awareness.

- Digital Inclusion: Recognizing the importance of digital access, we aim to promote digital inclusion by providing resources and support to individuals in underserved communities. Our fundraising efforts are directed towards serving rural areas and individuals who may not otherwise have access to the internet, thereby bridging the digital divide and promoting equal opportunities for all.

- Fundraising for Future Initiatives: While we currently operate on a digital platform, we are committed to raising funds and resources to support future initiatives, including the hosting of local events, gatherings, and community programs. Through strategic fundraising efforts, we aim to expand our reach and impact over time.

Article IV: Activities

Article IV: Activities

PixelQuest Ventures LLC is dedicated to providing a diverse range of online and offline activities aimed at fostering community engagement, creativity, and social impact. As an online-based group, the majority of our activities, approximately 70% of our total organizational time, are conducted online to support our overall group membership. Below is a detailed review of each activity, including pertinent information such as who conducts it, where it occurs, time allocation, funding sources, and how it furthers the organization's exempt purposes:

1. Online Membership Platform

- Activity: Providing an online membership platform where individuals can become members by paying dues.
- Conducted by: PixelQuest Ventures LLC administration, with support from PixelQuest Trade.
- Location: Conducted online.
- Time Allocation: Approximately 20% of total organizational time, with members actively engaging in online forums and discussions.
- Funding: Membership dues, primarily facilitated by PixelQuest Trade.
- Expense Allocation: Roughly 15% of overall expenses.
- Exempt Purpose: Facilitates community engagement by offering a platform for members to access exclusive benefits, fostering a sense of belonging, and encouraging participation in club activities, ultimately leading to personal growth and skill development.

2. Virtual Events and Fundraisers

- Activity: Hosting virtual events and fundraisers.
- Conducted by: PixelQuest Ventures LLC event planning committee, with member participation encouraged in organizing and attending events.
- Location: Conducted online.
- Time Allocation: Approximately 70% of total organizational time, reflecting our emphasis on virtual engagement.
- Funding: Proceeds from event ticket sales, donations, and sponsorships, facilitated by PixelQuest Trade.
- Expense Allocation: Around 25% of overall expenses.
- Exempt Purpose: Engages members and the broader community, raises funds to support the organization's growth, and promotes social impact through various initiatives, while providing opportunities for members to develop event management and organizational skills.

3. Community Showcases

- Activity: Providing a platform for community members to showcase talents and creativity.
- Conducted by: PixelQuest Ventures LLC community outreach team, with members encouraged to participate as performers or contributors.
- Location: Both online and at local events.
- Time Allocation: Approximately 10% of total organizational time, with members actively involved in preparing and presenting their work.
- Funding: Partially funded by event proceeds and donations, facilitated by PixelQuest Trade.
- Expense Allocation: Approximately 10% of overall expenses.
- Exempt Purpose: Promotes inclusivity and community engagement, fosters creative expression, and supports local talent while raising awareness about social issues, providing members with platforms to showcase their skills and gain exposure.

4. Physical Locations

- Activity: Establishing physical community hubs.
- Conducted by: PixelQuest Ventures LLC executive team and project managers, with members involved in community outreach and facility management.
- Location: Physical locations in communities.
- Time Allocation: Approximately 10% of total organizational time, with members actively engaged in planning and utilizing the facilities.
- Funding: Primarily funded through fundraising efforts and donations facilitated by PixelQuest Trade.
- Expense Allocation: Significant portion of overall expenses, approximately 30%.
- Exempt Purpose: Provides tangible spaces for community interaction, offers resources for empowerment (such as job assistance and educational programs), and advances social impact goals by creating inclusive environments for all, while offering members opportunities for leadership and community involvement.

5. Charitable Initiatives

- Activity: Supporting charitable causes and initiatives.
- Conducted by: PixelQuest Ventures LLC charitable partnerships team, with members encouraged to volunteer and participate in fundraising activities.
- Location: Both online and offline, collaborating with local organizations.
- Time Allocation: Approximately 10% of total organizational time, with members actively involved in volunteer efforts and fundraising campaigns.
- Funding: Funded through donations and fundraising events, facilitated by PixelQuest Trade.
- Expense Allocation: Around 10% of overall expenses.
- Exempt Purpose: Demonstrates commitment to community welfare, supports causes aligned with organizational mission, and contributes to positive social change by addressing pressing societal needs, while offering members opportunities for altruism and community service.

Through these diverse activities, facilitated primarily by PixelQuest Trade and driven by member participation, PixelQuest Ventures LLC aims to create a dynamic and inclusive community where individuals can connect, learn, and contribute to positive social change, both in digital

spaces and physical locations, while fostering personal growth and new experiences for all involved.

Article V: Management

The management and affairs of The Organization shall be conducted by its members, Board, or elected official. In accordance with the operating agreement adopted by the members.

Article VI: Dissolution

Upon the dissolution of The Organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(7) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose.
